Previous Action Items

- 2023 financial reporting for website [done through 2022! Woo!]
 - Waiting on CPA to get past tax season to close out 2023 bookkeeping
 - There's some complicated stuff because of how Dennis used PayPal as an intermediary
 - Have now moved to QuickBooks, and PayPal settings changed so this won't happen again

- Put vehicle policy out into the world
 - o Done
- Determine specific concerns from landowners about areas to focus on for optics this year
 - Certain people can't park in Frank's yard
 - Participant bus didn't have a good place to park this year after the road got paved; bus company was unhappy.
- Make progress on Long-term Planning Group [Dan sent email]
 - o Email sent; Iva, Tristan, Carly, Meytal expressed interest
 - Meeting scheduled

Vehicle/cart discussion

Participant asked about DIY "electric garden cart" type vehicle for hauling gear (no riding, detects assist when a human pushes/pulls it)

Current policy covers:

- 1) Roadworthy vehicles
- 2) Event operations UTVs
- 3) Art car(t)s
- 4) All other vehicles, motorized or human-powered

With the last category being totally disallowed, so perhaps electric cart is neither vehicle nor art car(t) and it's a non-issue as-written

Budget and Pricing

- See Dan email; TLDR:
 - Estimated budget \$220k
 - Propose average ticket price of \$165, including parking (remove separate parking pass), assuming 1400 tickets
 - Based on historical growth in costs and inflation, etc
 - Fraction of asking price that people pay with PWWC pricing has declined steadily
- If no advance parking registration, need to ensure we are capturing data that we want.
 - Trying to optimize gate time, eliminating cash box will help.
 - Can we avoid filling out parking placard? Allow print-at-home?
 - Discussion on demand/price elasticity

Land Use Agreements

- 2024 White rental agreement DRAFT
 - Sent to Kirk; awaiting feedback
 - Holding off on 419 and Triangle agreements until this makes progress

Nuthatch Update

- Still planning on Dennis memorial last weekend in May
- Work Bees also happening in coming weeks
